PLEASE READ ALL FEES ASSOCIATED TO SHOW

FEES:

Pre-Entry (midnight, 10/20/24): “All-You-Can-Show” + Stall Fri-to-Sat + 1 bag of shavings	\$200/Horse “All-You-Can-Show” + Fri-to-Sat stall + 1 bag of shavings
Post-Entry Fee (after 10/20/24) “All-You-Can-Show” + Stall Fri-to-Sat + 1 bag of shavings	\$225/Horse “All-You-Can-Show” + Stall Fri-to-Sat + 1 bag of shavings
Stall for Additional Night (Sat-Sun)	\$40
Office Fee (per Horse)	\$20

To receive pre-entry price, you must submit ALL show paperwork including form of payment by midnight on 10/15/24.

ALL Entries must include the following paperwork in order to receive pre-entry pricing:

- Completed Entry Form
 - Signatures Required
- All signed Documents and Releases
 - PFHA Membership Number
 - Current Coggins
- 30-Day out of state Health Certificate
 - Vaccination Record

Form of Payment - Emailed entries must include credit card payment using credit card authorization form.

4% credit card processing fee will be added to all credit card transactions.

(Check can be submitted at check in for payment in place of credit card, but entry must include completed credit card form)

Mailed entries must include check made payable to:

Ocala PFHA, or credit card authorization form.

Incomplete entries will not be marked as received.

Move In Date: Friday, 10/25/24 after 12:00 pm

Move Out Date: Saturday, 10/26/24 (or Sunday, 10/27/24, for an additional \$40 fee)

A one-time \$50 clean up fee per stall and/or tack room will be incurred for any left behind personal belongings and/or trash.

SHOW RULES & IMPORTANT INFORMATION

- It is important to PFHA that everyone in our shows has the best experience possible. If you have any needs which we could address in advance to make your experience better, or if you have any ADA accessibility needs, please contact Angel Lopez at (352) 286-4497. Please include with entry if you have any mobility issues requiring parking close to stalls or arena.
- ALL fees must be paid & paperwork completed before exhibitor back numbers are released.
 - 4% credit card processing fee added to all credit card transactions.
 - ALL horses will be charged a stall fee. NO grounds fees available.
 - A 50% refund will be issued for class entry fees with vet certificate after 10/16/24.
- Horses that submit a certificate in order to receive a refund will not be allowed to show in this event.
- \$100.00 handling fee will be charged for all returned checks/declined credit cards.
- CLOSE OUT: Failure to close out show bill on the last show day, 10/26/24 will incur an added \$50.00 to your show bill.
- If show bill is not paid in full, returned check or declined credit card is not paid in full within 2 weeks after notification, PFHA will be immediately notified of the non-compliance!
- ALL exhibitors must enter the arena when called by gatekeeper. It is your responsibility to be in warm up arena 30 minutes before your class! Barn calls are a courtesy!
 - Show Management reserves the right to combine classes if there are less than 3 entries in a class.
 - **SHOW MANAGEMENT RESERVES THE RIGHT TO REFUSE ENTRIES.**
 - Exhibitors are notified that any act of discourtesy or disobedience to the judges, officials or show staff, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee, other fees and may be asked to leave showgrounds.
 - Dogs must be on a leash on showgrounds.
